ROLE

OF LOCAL BODIES IN GOVERNMENT

The seminar held on the above topic urged revolution of powers to provinces and local bodies in the real sense. The honorable guests invited expressed their individual views and opinions upon this aspect of the ruling government. Amongst these esteemed guests were Senator Taj Haider, Senator Abdul Haseeb Khan, Mr. Saeed Ghani, leader of the opposition in the City Council and Mr. Muqtada Mansoor. A number of issues dealt with involved the Local Bodies Ordinance 2001, through arguments and identifications the Ordinance currently disposed off either negativity or contradiction and were creating gaps in the system. One issue dealt with in length which Senator Taj Haider was highly concerned about the Local Body Ordinance



2001. He was convinced that the Local Body Ordinance 2001 didn't devolve provincial government's authority or autonomy. Lacking the required responsibility and authority which should be appointed to provincial government was distinguished against district governments who were coinciding with provincial authority, in other words all havoc and chaos was broke. It is important to primarily identify why there was a need for the Local Body Ordinance 2001 to be introduced. Acknowledging the fact that Pakistan is a huge country with a good round of population, they need to be more organized in order to function and implement proper rule. The need of the district government and the provincial government was required.



This took off the burden from the Government and gave the opportunity for them to pay attention towards the national issues as well as the international issues. The government can assign a sum amount of money annually to provincial sectors and they further can appoint a sum amount of money to the district sectors that take care of administrative activities by managing, controlling and operating departmental offices of sewerage, horticulture, education and health facilities, housing and development projects etc. Now to think that if a single uniform government was present

matters it would be quite unsuitable and cause lack of focus on much more important issues such as aid and handling the trade deficit etc. To further understand the need of provincial and district authorities that Pakistan is broken down into 4 provinces within these provinces there are cities or districts which further are broken down into towns. Thus, there is a vital need for district government to take care of their towns both urban and rural and for provincial government to take care of these towns that fall under the specific district which falls under them.



As in opposition to the content of the Local Body Ordinance 2001, Senator Taj Haider highlighted that the document holds very little details on the duties and authorities which the provincial government possesses. For instance under



the section for the relation between the government with the district government, it states that the government has given the authority to the district government to collect provincial taxes or taxes in their area and the government pay speech out its guidelines and render advice to the district government to promote economic, social and environmental security of province all which rightfully be given to the provincial government. On the other hand the noted activities of the provincial government involve in diminishing disputes amongst departmental offices and district governments between two district governments. To provide

the government a complete report upon the inspection of all local governments or govern any issues linked to local governments. The whole document eliminates the existence and importance of the provincial body. It highly reflects the issues concerning the district body with its functions, order of people appointed, responsibilities, offences committed, ethics and many other aspects all but linked to the district government and none to provincial governments.



Senator Abdul Haseeb Khan dealt with the issues concerning the electoral programs lead for local bodies. He discussed the outline and criteria falling down for candidates who are interested in obtaining seats. A complete guideline is provided in the Local Body Ordinance 2001; listing down elements governing the elections such as it is performed after every 3 years so as to enable their installation on the 14th day of August of the year in which elections are held. The Chief Election commissioner performs the elections and appoints a number of officers to further assist him. Other issues which implied upon within

the boundary of electoral programs included qualification for candidate and electoral members, joint candidacy, electoral rolls, illegal conduct, bribery etc. Senator Abdul Haseeb Khan agreed with Senator Taj Haider for the

absence of the clear vindication of the autonomy to the provinces.

Mr. Saeed Ghani took a complete different perspective of the Local Bodies Ordinance 2001 for the application in Karachi, where he enlightened us upon how the 5 districts of Karachi have been coupled together into one big district leaving behind the rural areas to be dealt with them. Another vital issue when observing the Ordinance is that it has conveniently stated guidelines for urban areas and left out rural areas. There is no outlook or consideration provided for the rural areas which in itself depicts bias against urban and rural areas. Throughout



the document activities, rules and regulations, persons, offices all have been planned out in accordance to the outline of urban areas, there is no activity or performance methods implied for rural areas. He identified the need for district governments to remove discrimination and recognize the essential purpose and requirement of these local bodies. And not only to decrease the burden upon the government but to also take efficient care of the public and be able to solve their problems at a more personal and eye to eye grounds.



To conclude the seminar Mr. Muqtada Mansoor, pointed out in his paper that traced the developments of the Local Bodies Ordinance 2001, as any other document the Ordinance could evolve and bring changes as the years pass down and improvements can be seen. Though the document is very vague and discriminative in respect to urban and rural it is the duty of the government if they have introduced this system than to implicate it properly and completely. As the years pass down individuals similar to our guests will recognize the mistake and gaps in the system and provide their suggestions and advice. These

should be taken into consideration by the authorities and thus bring further improvement in the Ordinance for it to function effectively and as planned. There are some benefits achieved by the Ordinance since the public has been observing the many developments in our own cities and understand that the country has moved on the plight

of improvements and developments. Some credit can be given to this introduction and accept the slow yet eventual rapid movement it is providing us.

Col (R) Tahir Hussain, Former Rector of the Institute, presented mementos among the participants.

Earlier Dr. Muhammad Ali Siddiqui, Dean of the Faculty of Management & Social Sciences welcomed the participants & the audience.



MYSTICAL MYSTICS OF SUFISM

Sufism also spelled as tasavvuf and tasavvof according to the Persian pronunciation, is generally understood to be the inner, mystical dimension of Islam. A practitioner of this tradition is generally known as a Sufi. During the eighth and ninth centuries A.D., a new emphasis began



to develop within the religion of Islam. This emphasis was a reaction against the prevailing impersonal and formal nature of Islam. For many Muslims the Shari' ah, while seen as necessary, failed to satisfy their deepest spiritual longings and desires. The search for deeper meaning began with a pietistic asceticism, which in turn led to the development of the popular mystical side of Islam - known as Sufism.



Classical Sufi scholars have defined Sufism as "a science whose objective is the reparation of the heart and turning it away from all else but God." Or as "a science through which one can know how to travel into the presence of the Divine, purify one's inner self from filth, and beautify it with a variety of praiseworthy traits." In its early stages of development Sufism effectively referred to nothing

more than the internalization of Islam. According to one perspective, it is directly from the Qur'an, constantly recited, meditated, and experienced, that Sufism proceeded, in its origin and its development. Others have held that Sufism is the strict emulation of the way of Prophet Muhammad (S.A.S), through which the heart's connection to the Divine is strengthened.

Our esteemed guests invited to voice out their opinions and post importance upon issues which seemed of great struggles. Dr. Fatima Hussain, well-known Indian historian from Delhi University communicated in her lecture on 'Mysticism and Peace in Global Perspective'. During this



lecture she identified the advantage and favor which Sufism could offer to many conflicts and world problems. She also enlightened us that Sufism was not restricted to Islam. People contradict this by saying that Sufism has been borrowed of from other religions, 'outside religions'. Sufism is claimed to be derived and influenced by a number of religions for the construction of its many practices, manner of devotion, the chants, poems and dances, beliefs and functions and the symbolic paintings for its buildings. Religions which have had and still do have the above influence are Christianity, Hinduism, Zoroastrianism, Buddhism etc. Thus, not only has Sufism been influenced by other religions, but its mystic quest for spirituality has led it to embrace all sorts of religion, as abundantly shown in the writings of the great Sufi saints.

The argument between traditional and contemporary Muslims stands against the mystical doctrine of Sufism and its Sufis. Sufis claimed that it grew amongst the many gaps and cracks created and existing in Islam. They claimed that whatever was lacking in Islam towards strict devotion of God was fulfilled by their manner of

faith and worship. The argument for Muslim materialism lends support to the concept of a spiritual void in Islam - keenly felt by many Muslims as their civilization began to expand and come into contact with other religions. There was a hunger for more spirituality, along with the realization that despite all of the Shari' ah, Islam did not effectively deal with the problems of materialism. People coming in contact with other religions observed the keen devotion and dedication other religions had for their manner of worship towards God and felt there was some lack, some gap experienced by Muslims towards their worship to God. People started to question their own manner of worship and devotion towards Allah.

To further which Mr. Fakhar Zaman, Chairman of the Academy of Letters, added on that it was through this realization which turned people towards a more humanizing and civilizing society and to strain away from the extremist doctrine being used to brainwash



individuals. Sufism in itself makes people turn towards their own manner of dedicated worship. People understand by observing other's perform those rituals or activities which draw them closer to their God. Each of us is entitled to worship God in the manner we find ourselves comfortable with, since obviously turning to God is finding inner peace and asking for peace. He also emphasized the importance of including such a subject in the curriculum for students to understand its scope and use in a global perspective.

Understanding that the very strength of Islam was its reliance on a simple creed and the five pillars, as Islam spread these five practices become the uniting force and it soon became evident that anyone that anyone could accept this framework and step right into it as along as they claimed they believed in One God, it's creed and followed the 5 pillars of Islam, it was announced that they had become the devoted follower of God. But there was a need of certain individuals to differentiate themselves from the uniformed Ummah for their devotion was unlike of others.

They had nothing to do with the worldly matters as did the people who had accepted the framework of Shari'ah and continued with their materialistic matters. For the



Sufis their materialistic matter was their non-stop worship, devotion and love for God, their world of mystics. These individuals were on the look for something more filling for their hunger of worship and complete surrender to God. They were extremists when it came to worshipping God and believed that their life, their love, their purpose of coming down on earth was to showcase God their unstoppable and guaranteed sublimation to Him and to show that nothing could come in the way of them and God. Another reason for Sufis to link Sufism to Islam and claim it was Prophet Muhammad's way is because after the Revelation brought down on him. His path was turned towards God; he made every purpose of life, of existence towards the following of his Allah, his God. Every message, every action was for His purpose, for His happiness and to deliver His message to the people. What the Sufis don't realize is that he was a dear Messenger of Allah. A closely loved and cherished Messenger of God. He was destined to perform in such manner, it was his duty.

Islam is the means of a pure and easy manner to life within the constraints implicated by the Shari'ah. It is a religion for all those who accept that there is truly only One God and no other, but at the same time it doesn't restrict us from our daily life. It understood the future and its many developments that were arising in that time which depicted the future conditions. For which the Shari'ah has evolved to make our lives easier and more camouflaged with today's world the one coming after till the Day of Judgment Sufism on the other depicts that our sole purpose to dispatch on earth is to sublimely submit ourselves in the path of Allah. We are here only to worship him and heed his command and no other. For Sufis the earthly and worldly matter do not exist. They have retreated themselves towards extreme worship to Allah. No doubt Allah has claimed in his Book that we are supposed to devote ourselves in His manner and purpose of living. But He has not stopped us from trading, performing business, achieve

The reason why Muslim scholars collide against Sufis is because of the extreme thoughts and belief of Sufis they are not open to admit that there is a world, there are people. They believe that these factors are present to mislead them against their devotion and dedication to God. They believe that these elements exist to distract them of their primary mission for their existence on earth. On the other hand Muslim scholars have stated



that no doubt Allah has said to walk on His path and abide Him and to stay away from what He has abhorred. But it doesn't mean that out purpose on earth, our life be sabotaged by the undisturbed worshipping of God. Even Allah understands that we require moving on, bringing about different civilization as the years pass by. He to understand that new development is to come about and new eras are to be lived, passed and forgotten. The sole purpose of Allah to bring about the world and its people is to judge His followers, of their tests against the many temptations of the world with their faith and worship. The sole worshipping of Sufis is fruitless if they are avoiding the worldly matters. If they themselves have eradicated the elements of the world than what against are they proving their strong and strict devotion? If there is nothing to fight against than what is the name of their struggle? If they are not being distracted by something than what is the result of their worship and dedication?

Yes it is true that Sufism didn't prevail from the start of Islam and came about 200 years after the introduction of Islam, why is this so? Because this method of worship wasn't identified by Allah and His Messenger, this term or method came about by the introduction of a group of individuals who probably where the many groups who were involved in trying to corrupt Islam and its functions. The Qur'an is very complex in nature; its understanding can bring about many interpretation of one verse. If in itself has not mentioned the word Sufi and something related to it than how can people lean towards it? How can people

Sufism is yet another innovation of groups of individuals who wanted to state that Islam and its Shari'ah has not stated the rules and regulation of devoting oneself towards Allah. But isn't that obvious that every individual has his/her own manner and method of devoting themselves to Allah. Have they not understood that each individual is free to exhibit their own feelings, their own way of worshiping Allah? It is up to Allah to decide who to judge whose method of worshipping. If you want to turn towards Allah and forget the world and worship blindly towards Him that is your decision. We are no one to lead the people towards another new religion of another new practice of Islam.

In conclusion, the argument and disagreements between traditional Muslim scholars and the Sufis is similar to any argument Muslim scholars experience with the many other branches of Islam practices. Each branch has its own method of belief and practices and along with that they believe theirs is the right path to Allah. Simple conclusion to all this confusion is to keep these practices to you, those who have been born within those practices will practice those beliefs and methods, and there is no need into going investigating and proving each others' practice wrong. It is for Allah to decide and it is our duty to worship and devote towards him in our own manner which we believe is right. The bottom line to this whole chaos is to worship One God to believe in His Messenger, His Angels, His Prophets and His Book. The end result that Islam tries to achieve for all Muslims is to distinguish between the worshipping of idols and worshipping of true One God. The rest is for Him to observe, to judge and disclose is result on the Day of Judgment.

Dr. Muhammad Ali Siddiqui, Dean of the Faculty of Management and Social Sciences warm heartedly welcomed the guests and applauded on their sense of knowledge and suggestions on the topic

Dr. Riaz will be the only scholar participating from Pakistan.



Editor has commented on Dr. Shaikh's paper in the following words:






qualifications that can be considered.

The seminar was a part of SBP's endeavour to promote Islamic Banking as a parallel, competitive and Shariah complaint banking system in the country.


Addressing participants of the Awareness Programme, which was held at State Bank of Pakistan, Karachi yesterday, Mr. Inayat Hussain, Executive Director SBP, said that availability of a sound Shariah-based regulatory and supervisory framework is facilitating innovation and development of Islamic Banking in the highly dynamic banking market of the country.

He informed the participants about measures taken by SBP to promote Islamic banking in the country and the progress achieved so far. He said that in a short span of time, branch network of Islamic banks has grown to over 550 branches and the share of Islamic Banking has reached 5.5 percent in deposits and 5.3 percent in assets, as of September 2009.

Renowned Shariah Scholar, Mufti Munib-ur-Rehman spoke about the Shariah aspects of Islamic banking system and stressed the need of public awareness in making Islamic banking a success. Mufti Irshad Ahmad Aijaz referred to basic concepts of Islamic finance and explained the objectives of Islamic economics, banking and finance. Other Islamic Banking practitioners discussed operational and commercial aspects of Islamic banking. It was highlighted that Islamic banking offers competitive pricing for customers and can serve all the business sectors through a wide range of products.

State Bank of Pakistan established Islamic Banking Department on 15th September, 2003 and has been entrusted with the task of promoting & developing the Shariah Compliant Islamic Banking as a parallel and compatible banking system in the country.

The program was attended by a large number of people representing Securities & Exchange Commission, Chambers of Commerce & Industry, various industry associations, academic institutions, and Islamic, conventional & microfinance banks.



SIGMUND FREUD: THE FATHER OF PSYCHOLOGY

Sigmund Freud was born at a small Austrian town Freiberg, Moravia on May 6, 1856 in a Jewish family. He was the eldest child among seven and had two step brothers as well. At the age of four he moved to Vienna with his family.

Freud was a brilliant student since his childhood. He used to live in a crowded apartment and had his own separate room and an oil lamp to study by. Freud received classical education by studying Greek & Latin languages. He had an excellent command over German, French, English, Spanish and Italian languages.

His childhood dream was to become a great Austrian General or Minister of State. As he belonged to a Jewish family, all professions except Medicine and Law were closed to him due to Anti-Semitic climate of the time (according to the Library Press, 1973, Anti-Semitic is prejudice against or hostility towards Jews, often rooted in hatred of their ethnic background, culture, or religion). He took admission in the Faculty of Medicine in the University of Vienna in 1873 and received his M.D degree in 1881. He started his career as

a research assistant at the Institute of Cerebral Anatomy and did his research on comparing adult & fetal brains. Soon he resigned his post and started his private practice as a neurologist.

Sigmund Freud's career turned in the year 1885 when he went to Paris for further studies in neurology. Freud was married to Martha Bernays in 1886, had three daughters and three sons.

In 1895 Freud published his first book entitled "Studies in Hysteria" alongwith Josef Breuer, a distinguished Viennese physician. In 1900 Freud produced another outstanding work entitled "The Interpretations of Dreams".

The work for which Sigmund Freud is known as a Father of Psychology was the first comprehensive Personality Theory which required forty years of active writing & clinical practice. Some more important works include "Introductory Lectures on Psycho Analysis (1920), The Ego and the Id (1923), Future of an illusion (1927) and Civilization and its Discontents (1930). Sigmund Freud has also received Goethe Prize, A German Literary award of high prestige- in 1930, for his work on psychology and German literary culture.

Sigmund Freud suffered from throat and jaw cancer at the age of 67. He died in London, England at the age of 83 on September 23, 1939.

even be able to make substantial results. So it is in the best interest of the University and its students to encourage such events and take part to not only create the awareness of the University but to also provide a strong background for the students.



The story starts late one night a few years ago, with MIT Professor Marin standing in his pajamas, staring at his cell phone on the kitchen counter. It was probably the sixth time that month that he was awakened by his mobile phone beeping to let him know that he had forgotten to charge it. At that moment, it occurred to him: "There is electricity wired all through this house, all through my office-everywhere. This phone should take care of its own charging!" But to make this possible, one would have to find a way to transfer power from the existing wired infrastructure to the cell phone-without

wires. Soljacic started thinking of physical phenomenon that could make this dream a reality.

WiTricity was founded in 2007 to commercialize an exciting new technology for wireless electricity invented two years earlier at the Massachusetts Institute of Technology (MIT). A team of physicists, led by Professor Marin Soljacic, developed the theoretical basis for this novel method for wireless electric power transfer in 2005, and validated their theories experimentally in 2007.






It is like the magnetic fields of two properly designed devices with closely matched resonant frequencies can couple into a single continuous magnetic field. Prof. Soljacic's team showed how to use this phenomenon to enable the transfer of power from one device to the other at high efficiency and over a distance range that is useful for real-world applications. This "strong coupling" enables the devices to exchange energy via magnetism, and avoids the potential safety hazards and inefficiency often associated with radiated electro-magnetic energy. Their demonstration of wireless power transfer showed a 60watt light bulb being illuminated from a power source over 2 meters away.

This demonstration achieved broad media attention when it was announced, indicating both the intense public interest and commercial need for wireless power transfer.

Cell phones, game controllers, laptop computers, mobile robots, even electric vehicles capable of re-charging themselves without ever being plugged in. Flat screen TV's and digital picture frames that hang on the wall-



over room scale distances, and with high efficiency. Wireless electric power that is safe for people and animals. Wireless electric power-imagine no more... it's here!

Witricity having electricity carried through electro magnetic waves could be cause for nervousness or even cancer. Another major objection would be the theft of electricity through the wireless waves. If you thought theft of broadband internet through wireless network cards was a problem you could easily surmise that

theft of electricity would be an even major concern. Considering the fact that people pay a lot more per month on electricity you would assume there would be people stealing it via witricity wireless devices. We will have to wait and see what may happen. For right now we can only guess as to what the risks might be.

Pakistan Ashisvements in Test Cricket

The Pakistani nation has a very sensitive relationship with cricket. These diehard fans of cricket cannot accept defeat at any cost and by any means. The craze of the cricket in Pakistan increases day by day, year by year. Pakistan was given Test Match status on July 28, 1952 and the first captain of the Pakistan national cricket team was Abdul Kardar. Pakistan played its first test match in Delhi, in October 1952, in which India won the test series. Pakistan made its first international tour to England in 1954 and drew the series after a memorable victory at the Oval. Pakistan played its first home test match in Dacca (the then East Pakistan), in January 1955 against India. This article present some glimpses of the glorious moments of Pakistani cricket team in test matches.

1st Ever Test Match Won: Pakistan had not waited too long for its first victory in test cricket. Pakistani team opened their accounts by winning test series against India. Although, New Zealand, India and South Africa took almost 26, 20 and 17 years and 6 series respectively to taste the triumph.

This match was held on 26th October 1952 in Lucknow, which was a four days match. Fazal Mehmood, the hero of that match, took 12 wickets. Moreover, Nazar Mohammad scored an unbeaten century. Pakistan won that match by an inning and 43 runs. That was a successful start of a newly self-governing country's cricket team who had just entered into the test cricket arena.

1st Ever Home Ground Test Series Won: This milestone was achieved against New Zealand in 1955-56 season in home series. However, New Zealand was not considered as a strong side, but to get going and gain confidence,

Pakistan won the three match series with 3-0. Imtiaz Ahmed was the batting hero with 284 runs and Zulfiqar Ahmed the unsung bowling hero of Pakistan took 19 wickets in 3 matches. Pakistani bowlers dominated this series, H Kardar and K Mohammad also finished the series with 10 and 13 wickets respectively.

1st Ever Overseas Test Series Won: Victory in an overseas test series always put a significant impact on the country's achievement. To accomplish this landmark Pakistani cricket team waited for almost 20 years. This high point was also reached by winning against New Zealand, the same opposition, Pakistani cricket team had registered their 1st ever test series victory.

There was another three match series which Pakistan won by 1-0 in 1972-73 season. The only match won by Pakistan was in February, 1973. The top four run scorers of the series were from Pakistan. Sadiq Mohammad and Mushtaq Mohammad ended the series with highest run scores of 366, and highest batting average (105 with 314 runs) respectively. Moreover, Intikhab Alam was dominated in bowling wicket statistics. Mushtaq Mohammad was the hero of that match. He completed the match with a double hundred and a five wicket haul with overall tally of 7 wickets.


Biggest test victory (up till now): Pakistani nation cannot forget Inzamam's 329 runs inning against New Zealand (Pakistani team achieved many milestones against New Zealanders) at Lahore in May 2002. He is the second after the Great Hanif Mohmmad. Pakistan won that match with an inning and 324 runs. The result of this match is still registered in record books as 5th largest margin of victory in test cricket and highest victory for




